CRITERIA TO BE AN ELEVARIAN: We are looking for a candidate who has a rare mix of confidence, excellence, curiosity and humility - and who has demonstrated skills / attributes based on the following criteria:

- 2 to 4 years of legal transactional experience at a law firm / fund / company in general corporate / PE / VC practices or a similar background, with a willingness to unlearn and relearn at Elevar.
- Demonstrated legal and transaction skills, and exceptional communication skills in English (written and spoken) with a bias for simplicity and clarity.
- An entrepreneurial mindset (functioning in an agile work environment with a high degree of ownership and accountability), attention to detail (can find a needle in a haystack), a willingness to work hard / take ownership (bias for immediate action), a sense of humor (ability to laugh at oneself), a team player (organizational goals over individual credit), a deep desire to work at Elevar and the ability to take instant feedback (an opportunity for growth).
